## 1.1 INTRODUCTION

Kamakhya Pemton College, Hiyangthang is an undergraduate co-educational institute with 18 departments catering 24 programmes in Bachelor of Arts (B.A.), Bachelor of Science (B.Sc), and Bachelor of Vocational courses. The institution is located at Hiyangthang in Imphal West District of Manipur. The college was established on 13th August, 1981 with an area spanning 8.74 acres under CS. Dag No. 2208 of Village No. 106, Hiyangthang. It is affiliated to Manipur University and recognised under Section 2(f), 12(b) of the UGC Act of 1956 on 1st February, 2005. After having received lump-sum grants since 2001-02, the college on 25th October, 2021 became a Grant-in-Aid College Vide. No. 7(2)/26-3/2021-HE order of Government of Manipur. The institution has completed more than 40 years of existence. It has been an institution catering to the needs of stakeholders and providing quality education with pride and success. The college stands for quality and excellence, gender equity and social welfare for the benefit of the larger community. The college has qualified teachers and dedicated staff members who are committed to the achievements of its goals and objectives.

Codes of professional ethics guide all stakeholders of the College about its principles of integrity, accountability, inclusiveness, commitment and sustainability. All stakeholders work within the institutional policies and practices so as to satisfy the Vision and Mission of the College. The College practices a well-structured system of mentoring to provide proper guidance to the students not only in choosing the right career path but also to help them to become confident and emotionally secure individuals. The College is committed to make students conscious of their social responsibility through Community outreach programmes, extension services organized by NSS Units and College Alumni to enhance students' social awareness, community participation and sensitivity towards the upliftment of various sections of the society. Untiring efforts are made to instill the values of mutual trust, team work and promotion of social capital, sharing of knowledge, skills and resources to create a vibrant society at large. There is a paradigm shift in the educational focus with the implementation of NEP- 2020 in HEIs; teachers are urged to move from imparting knowledge to becoming mentors, encouraging self-learning, innovation and creativity amongst students. Further, they work towards building leadership skills, problem solving and envisioning reforms. To make this institute of higher education a center of excellence by promoting knowledge, innovations and finding its applications by tapping the potentials of staffs and students.

## **1.2 Strength, Weakness, Opportunity and Challenges(SWOC)**

### **Institutional Strength**

Kamakhya Pemton College is a co-educated institute with a history of more than forty years with high reputation owing to its selfless service, academic leadership, value oriented education and transparent governance. A harmonious relationship between the members of management i.e. the Governing Body(s) with staffs both teaching and non-teaching, students along with their parents defines the outcome of the college. Immense diversity among students with regards to variety of talents, par-excellence in sports and extra-curricular activities marks the essence of joyful learning along with traditional education based in classrooms. A highly committed, dedicated and resourceful faculty, student centric teaching

methodology is adopted in all the departments of the college. Kamakhya Pemton College's Research and Development Cell formed in line with UGC regulations encourages research activities among faculty and students by organizing various academic seminar, conference and symposia to keep abreast with the ever changing landscapes of research and development.

- The college has a well-designed campus with state-of-the-art robust modern infrastructure that enhances the overall learning experience and contributes to students academic and personality development.
- An active Internal Quality Assurance Cell (IQAC) plays a pivotal role in monitoring, augmentation and sustenance of overall quality of the institution.
- Student feedback is critically analyzed and is used for improvement in all processes. Curriculum

feedback from various stakeholders including students, teachers, parents, alumni and industry are taken accordingly.

- Lesson plans are prepared in every programmes and courses for integrating Teaching Learning.
- Transparency and fairness in admission process and reservation to weaker sections of the society is accommodated in admission procedure.
- Outcome Based Education (OBE) model is followed in the college with defined programme(s) and course outcome(s) and their attainment, measurement are based on Manipur University's LOCF (Learning Outcomes-based Curriculum Framework)
- The college has a well-established mentor-mentee system.
- The college gymnasium has been upgraded to cater for the needs
- ICT and Learning Management System-MOODLES are integrated to keep with the changing tides of information technology based education system.

### **Institutional Weakness**

- Being comparatively new and an emerging college, it has yet to fully establish into the consultancy services to provide placement for students.
- Being a relatively new entrant as a Government- aided College in the year 2021 only; there is a big financial crunch and very limited number of approved posts which acts as a big hindrance for overall development of the college.
- There is an urgent need to increase the percentage of Government approved permanent faculty(s) for a balanced overall growth of the Institution.
- Need to initiate exchange programmes and collaborations with other universities and institutions both at the National and International level.
- There is a greater need to empower teachers with skill-based training and hands- on practical knowledge within the college system with the institutionalization of New Education Policy - 2020 in Manipur University's Curriculum under Choice Based Credit System (CBCS) from the academic session 2022-23.
- There is a greater need to involve more teachers in Curriculum Development to meet the needs and current demands of review, revision and constant changes by participating in setting questions and as examiners to get hands on experience.

As of now, there is no NCC unit in the college to instill a sense of patriotism and service to the nation among the students.

### **Institutional Opportunity**

- The College is geographically located in a well connected Mayai Lambi National Highway NH137-A in the vicinity of Holy Ima Lairembi Temple area for playing an important role in creating opportunities for students as well as for the staffs.
- Being a Co-educational institute, the inherent system improves interaction, mutual respect between boys and girls, promotes gender equality and a diverse atmosphere that matches the real world.
- The college hostel facilities for boys and girls are provided to give affordable accommodation to help promote social interaction and give a sense of coordination and cooperation.
- Regular evaluation system with different modes of assessments like Assignment, Presentation, and Project work along with continuous internal examinations is needed to assess students' progression.

- There is a greater need to have more Industrial visits and educational tours organised for the students.
- College Central Library may be opened 24x7 to encourage student's self-study and preparation for competitive examinations.
- The college can further strengthen academia-industry collaborations keeping in view the need for internship and industry-based experience for further employability as and when the students passed out from the college.
- The quality audits like green audit, energy audit, environment audit and gender audit may be conducted annually, as it strives to create a model of education that is based on fostering a culture of eco-friendly practices and making the campus environmentally sustainable.
- Institution may make efforts for adding more Value-added add-on certificate courses imparting life skills, soft skills and other employable skills in the forthcoming years.
- Post Graduate programmes may be started in the college for few selected departments in the coming years.

### **Institutional Challenge**

- Research aptitude needs to be infused in the faculties.
- More programmes on Research Methodology needs to be organised and resources for the same may be generated.
- Concerted efforts may be made by the faculty to design e-content such as: e- PGPathshala, SWAYAM, other MOOCs platform NPTEL/NMEICT/any other Government initiatives & institutional Learning Management System.
- Need for more Faculty Development Programmes (FDPs) to be conducted in the institution.
- Tracking of student progression is time consuming and cumbersome. It requires dedicated manpower.
- With increasing student's strength every year, more Government approved posts is need to cater to the academic demands.
- None of the college faculty is registered as a research guide due to the policies of the affiliating Manipur University's Rules and Regulations.
- Establishment of new departments to boost the morale and employee engagement.

## **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

Curricular Aspects are greatly inspired by the New Education Policy-2020, the College adheres to the core values of dedication, hard work and commitment as encapsulated in the motto of igniting the sparks of ambition, empowering students to dream boundlessly embracing lifelong learning, excel beyond expectations and flourish as they navigate their educational pathways. The syllabus and curriculum followed by the College is based on Manipur University's LOCF. It is a challenge to achieve the curriculum objectives, but the teachers of the College have evolved innovative and effective ways of delivering curriculum content that is specifically moulded for the students of our College. The College has provided computers to the entire department of the college with two classrooms are ICT enabled and the entire campus is Wi-Fi enabled. This has greatly felicitated the implementation of the curriculum as important online data bases of research journals, which the College and the University subscribes to, are available in the classroom as an aid to teaching. The institute prioritizes the importance of social and human values, professional ethics, gender equality, health and hygiene and environmental respect in their curriculum. To promote these values, they regularly conduct programs such

as seminars, workshops and invited lectures on topics such as saving and educating girls, women's empowerment, gender issues, health awareness, *thang-ta* and yoga. The faculty regularly sends feedback to the College regarding the curriculum with suggestions for restructuring and improvement. The emphasis is on interdisciplinary and experiential pedagogy that integrates issues of gender, language, environment, human rights and information technology. The College organizes regular seminars, special lectures, educational excursions and trips along with faculty development programmes and training modules for the effective implementation of the curriculum. To evaluate the curriculum delivery and its effectiveness, the College Internal Quality Assessment Cell (IQAC) has initiated feedback systems for both students and the faculty. The College in recent years introduced an online feedback system for the students from the next academic year.

### **Teaching-learning and Evaluation**

The unwavering commitment and constant effort of the institute lie in the teaching-learning process that aimed at imparting knowledge to students from diverse backgrounds and nurturing them to become capable and responsible citizens. The strength of the college is its effective teaching methods for enhancing lifelong learning skills among our students. The faculty emphasise on the student centric methods in teaching-learning process. The institute has a diverse student population with most coming from the local community including number of students from weaker sections of the society, OBCs, SC, and ST. Upon admission, the institute assesses each student's learning level and organizes special activities to accommodate both advanced and slow learners. The faculties at the institute implement student-centric teaching methods such as Experiential Learning, Participative Learning and Problem-Solving Methodologies. The integration of Information and Communication Technology (ICT) into education tremendously enhances teaching-learning process by fostering interaction, digital literacy, and improving education quality as educators blend technology with traditional methods to streamline information sharing and promote educational standards in the modern landscape. Teachers are encouraged to acquire higher qualifications and awards. As a result, numbers of faculty members have been awarded with Ph.D. and received awards and recognition.

Our college places a strong emphasis on transparency and accountability in the examination and assessment procedures under the guidelines and regulations given by Manipur University. The institute has a mechanism to deal with grievances related to University and College examinations ensuring that the academic pursuit is transparent, time-bound and efficient. The institute has defined Program Outcomes (POs) and Course Outcomes (COs) for each program and course by using direct and indirect methodologies to assess these outcomes. Program Outcomes, Program Specific Outcomes, and Course Outcomes, along with detailed course contents are accessible on college website ensuring that students are well-informed through orientation programmes at the beginning of each semester's classes. For attainment of Programme Outcomes and Course Outcome, institution collects feedback from the students and teaching staff for measuring the system of teaching, learning practices, student's attendance for effective in teaching learning and evaluation.

### **Research, Innovations and Extension**

The College has established Institutional Level Biotech Hubs (IBThubs) by Department of Biotechnology, Government of India under Special Programme for North Eastern States of India. Teachers have received grants for IBT HUB and Foldscope Research from the Department of Biotechnology, Government of India. The IBT hub provides basic biotechnology infrastructure facility for students, faculties, researchers of individual institutions as well as nearby institutions. The institute has established cells, clubs and committees for the instilling creativity, professional and domestic skills. College has well-equipped media-lab, to produced lecture

talks, news bulletins. As a part of technological advancement, Moodle LMS has been implemented in the college and simultaneously conducted FDPs to train faculty in its usage and enhancing ICT facilitation in the college.

Faculty members published 6 research papers in UGC CARE and total of 14 books, 26 edited book chapters and 1 proceeding in Microcosmos conference were published during the assessment period. Institution, with its consistent effort has contributed articles to reputed journals. Research and Development cell of the college creates research ambience in the college which results in academic publications by faculty and students. Student exchange and faculty exchange programme are in practice.

The institution felt the importance of sensitizing students regarding their social responsibility. With this purpose, the institution conducted activities such as Blood Donations, Cleanliness Campaigns, Environmental Awareness Campaigns, Health and Hygiene related activities and Voter Awareness activities, Gender Awareness activities are regularly conducted to promote dignity of work and awareness of Social, Environmental and Health issues. During any disaster, college contributes a number of awareness, sensitization drives and outreach programmes have been conducted in order to fight during the recent Covid 19 pandemic. Sanitizer production and its distribution, face mask production and distribution were some of the major initiatives taken up by the institution to fight the pandemic. Every year our NSS units organize special camp(s) in adopted villages; such extended services help in developing students who are humane and holistic in their personalities. Institution collaborated with a good number of organizations in conducting student/faculty exchange programs, seminars, training programmes, certificate courses, counseling and co-curricular activities programs.

### **Infrastructure and Learning Resources**

Kamakhya Pemton College hosts robust infrastructural resources which are aesthetically pleasing and designed to ensure maximum academic utility. The college infrastructure ensures maintenance of high academic standards and also facilitates a wide array of co-curricular activities. The College is well equipped to provide a healthy and conducive learning environment that promotes all round development for its students and faculty members. Students are encouraged to keep the premises neat and clean which automatically adds to a healthy environment for teaching and learning.

It has expanded its infrastructure facilities to one academic and administrative block, various cells and committee offices, 79 class room, 14 laboratories, one central library, department libraries, 3 seminar halls, 1 multipurpose indoor hall, 1 auditorium, hostels for both boys and girls, and one Guest House. The college has 14 meticulously maintained laboratories to conduct experiments for students and researchers. The institute has three seminar halls, an auditorium, and a court room dedicated to hosting seminars, workshops, conferences and invited lectures for both students and faculty members.

The institute provides sufficient space and facilities for Yoga practice to college community. Following the implementation of NEP 2020, Yoga has been incorporated into the curriculum as a value-added and skill enhancement course. The college has implemented Moodle LMS for online teaching and learning since 2023-24 session. These venues are fully equipped with LCD projectors, Wi-Fi connectivity, raised platforms and a comprehensive public address system. The college has a comprehensive and well- equipped IT facilities for effective teaching-learning, evaluation and administrative functions; internet connectivity, departmental

LAN Ports, Wi-Fi access points, CCTV surveillance systems, Interactive Smart board and Electronic Whiteboards, Computer science labs, educational technologies, College management system, library facilities, media/recording lab and printing facilities. The primary objective of the College Central Library is to promote a conducive learning atmosphere and offer appropriate books or information to the intended users promptly. Library is currently operated within a semi-automated framework using Integrated Library Management Software (ILMS) KOHA 23.11.00 version enhancing library operations.

### **Student Support and Progression**

Student support and progression assesses the overall support systems in place within the institution to foster holistic development and progression of students, both academically and personally to demonstrate a commitment for creating an inclusive learning environment. The College support systems and mechanisms are in place for students of the college by ensuring that the institute provides a conducive environment for holistic development. Apart from the national and state level scholarships which are awarded to the meritorious and/or needy, Governing Body and the alumni contribute towards freships and fee concessions. The availability of financial aid, scholarships, and other support mechanisms for students from diverse backgrounds is considered to ensure that all students have equal opportunities for academic success.

In today's dynamic and fast-changing world, individuals need to continuously enhance their skills to stay relevant by adapting new technologies and embrace lifelong learning of skills. Soft skills are non-technical skills that are essential for effective interpersonal communication, teamwork, leadership, and problem-solving. The institution is expected to have a robust counseling and guidance system to assist students in academic and personal matters, facilitating their overall development and well-being. The college has an effective Career guidance and placement services to facilitate the smooth transition of students from academics to the professional world. The institute has a well define Grievances Redressal cell to address any concerns or complaints raised by students along with feedback Redressal systems.

NAAC looks at how institutions monitor and support students in their academic progress. It considers factors such as dropout rates, progression rates, and the overall participation of students in various academic and extracurricular activities.

Private vehicles are not allowed to enter the campus and proper signages are placed at proper sites. The Department of Environment and Climate Change, Government of Manipur has also conducted detailed Environmental Green Audit and Energy Audit of Kamakhya Pemton College, Hiyangthang and issued a certificate on it. The Institute has an area covering of 8.74 acres of which 2.91 acres is built-up area for infrastructural development purposes and also targeted to have 79 classrooms and well equipped 14 laboratories for systematizing and standardizing the learning process, ensuring wider access to knowledge and skills. The Kamakhya Pemton College is also taking steps to properly dispose of waste and encourage recycling. These initiatives showcase our college's commitment to environmental responsibility. Our college is also performing well in academic during the last five years. During the last five years (2019-23), 1656 number of students appeared in the Honours Course Examination and 1532 students were cleared the said Examination (92.51%). On the other hand, 1162 number of students was appeared in the General Course Examination during 2019-23 and 1008 students cleared with passed percentage of 86.75.

The implementation of ABC system is ongoing, and our college will have flexibility in adapting their approaches within the overall framework set by the National Education Policy 2020. b) All the admitted students under NEP-2020 are registered under the ABC system to avail the benefits of multiple entries and exit in the chosen academic program. But, as of now, there is no detail on it since the result for the 1st</p>

semester examination is yet to come out. c) The Institute is on a mission to create a truly internationalized educational experience. **Response:**

Kamakhya Pemton College is affiliated to Manipur University. The curriculum and syllabi designed by the Manipur University which is as per the UGC curriculum guide line. The college is offering 3 years B.A., B.Sc. and B.Voc. Undergraduate programs with semester system of examination since 2011. And, with the implementation of NEP-2020, the new curriculum emphasizes aspects like multidisciplinary, critical thinking, holistic development, skill development, and better preparation for careers in higher education.

The Academic Council, Admission and Examination Committee with the support of IQAC of the college prepares academic calendar, time table for lectures/tutorial/practical, and mentorship. Respective HODs then distributes the syllabus and classes among the faculties and they prepare curriculum planning accordingly for an effective curriculum delivery. Thus, every teacher is entrusted with the responsibility to cover up the assigned syllabus within stipulated time and in case, any teacher fails to finish his/her syllabus in the given time, the teacher has to arrange extra classes. Ensuring the academic calendar effectively allocates time for teaching, learning, and assessment activities.

For effective system of curriculum delivery, there is need for well-maintained class rooms with modern equipment. The faculties also adopted various methods of teaching like presentation, assignments, etc. in addition to regular class room activities. Internal assessments through diverse methods like tests, assignments, presentations, projects, and field studies also provide a more holistic evaluation of student learning. The marks for internal assessment of the students are sent to Manipur University before the commencement of end-semester examinations conducted by the university.

Collecting feedback from students on teacher's performance helps identify areas for improvement and promotes faculty development. Feedbacks in prescribed format are obtained from every student of all the semesters about the overall performance of the teachers. Head of the Institution also convenes for conducting periodic faculty meetings, which will facilitate discussions on student's attendance and feedbacks, leading to ongoing improvements.

The college has various academic oriented Cells like Career Guidance and Counseling Cell, Research and Development Cell, etc. Career Guidance and Counseling Cell plays a crucial role in supporting students in understanding their strengths, weaknesses, interests and values to identify suitable career options. The Research and Development Cell organizes seminars workshops and research related activities for both students and teachers. Induction program is annually conducted for the newly admitted students and guardians at the beginning of the academic session to make them aware of code of conduct, academic calendar, curriculum structure and process of evaluation.

## 2.5 Evaluation Process and Reforms

### 2.5.1

**Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient**

**Response:**

Our college places a strong emphasis on transparency and accountability in the examination and assessment procedures under the guidelines and regulations of Manipur University. The total marks for each courses consisting of 25% for internal assessment and 75% for end-semester examination conducted by Manipur University. The Admission and Examination Committee ensures fairness and transparency in both internal and external assessments to improve the grievance and redressal system within a time bound and efficient framework.

**Internal Assessment:**

- 1.The primary responsibility of the Admission and Examination Committee is to ensure the Academic Calendar is available on the college website, college notice board, ensuring accessibility and awareness among college community.
- 2.The internal assessment is allocated as follows: 20% for Written Examination test/Assignment/ Seminar/presentation/Field work/ Project work/Case studies, and 5% for attendance.
- 3.Attendance calculation commences from the date of class commencement or date of admission, whichever is later.
- 4.During the induction program, the newly admitted students are emphasized for the value of internal assessment with fairness and transparency.

5. Throughout the semester, various assessment activities are conducted, including unit tests, class tests, assignments, classroom seminars, project work evaluations, practical assessments, and study tours providing feedback opportunities for improvement.
6. Any grievances regarding fairness and transparency of internal assessments are directed to the examination committee for redressal.
7. The institute provides students with various formal channels to address grievances, including the complaint box and direct communication with the Exam Committee, ensuring accessible avenues to voice their concerns.
8. If any student questions the fairness of internal evaluation process, they may for a re-evaluation through a written application to the principal. The Committee promptly addresses and resolves student grievances.
9. It is mandatory to display marks obtained in all the internal assessments of each semester on the notice board and college website to ensure clarity, fairness, and transparency.
10. The committee diligently oversees to enhance student performance in the end semester examinations through timely internal assessments, efficient evaluation and tabulation procedures, and transparent results display on department notice boards and website.

**University end semester examination (external examination):**

1. The end semester examinations conducted by Manipur University strictly adhere to the rules and regulations set forth by the University.
2. All students enrolled in the 1st semester must register with the university's Academic Bank of Credit, and their ABC-ID should be submitted to the Institute before the 1st semester end examination.

The teaching faculties are engaged in discussions regarding the alignment and reflection of curriculum and syllabus by the Manipur University to make academic standards and expected learning outcomes of both Programme Outcomes (POs) and Course Outcomes (COs) in each department of the college. The Learning Outcomes adhere to meet the needs of learners and it is clearly articulated and displayed on the college website.

1. **Advanced Knowledge:** It concerns to the development of core subjects and discipline-specific courses that offer learners the opportunity to engage in deep study, critical thinking, analytical reasoning, problem-solving activities, research, and commitment to innovation within their chosen discipline. Our aim is for students to comprehend sustainability challenges spanning from local to national, and global, fostering a comprehensive understanding. The study of learning encompasses theory and practical components including tutorials, dissertations, projects, internships, presentations, assignments. Within this discipline, core subjects are complemented by discipline-specific outcomes, which delve deeper into advanced knowledge and skills at different course levels for achieving and fulfilling the outcomes.
2. **Exploring Subjects of Knowledge:** This knowledge acquired from the elective courses is typically generally chosen from areas unrelated to the core disciplines. The course outcomes are displayed on the website at different stages of the courses.
3. **Communication Skill:** In both old and new systems of education, the development of communicative skills is fostered through the study of General English, Regional Development, Regional Language, and Environmental Science. The course outcomes of these subjects encompass understanding basic General English, Regional Culture and Language, Climate Change, Pollution, Waste management, Sanitization, Conservation of Biological Diversity, Forest and Wildlife Conservation.
4. **Hands-on Base Skill/ Job Oriented Skill:** The Skill Enhancement Course (SEC) introduces in the session, 2022-23 aims to cultivate job-oriented hands-on skills among undergraduate students. The departments across disciplines have implemented these practices to foster practical knowledge among students. Examples such as Bio fertilizer (Botany), Mushroom Cultivation (Biotechnology), and Aquarium Fishkeeping (Zoology) are displayed on the college website.
5. **Ethical Value based Skill:** Following NEP-2020, the institute has devised strategies to introduce twenty different Value Addition courses selected from the pool of courses provided by Manipur University. The course learning outcomes of these programmes aim to develop humanistic, ethical, constitutional, universal ideas such as truth, righteous conduct, peace, love and affection, nonviolence, gender equity, scientific temper, and the value of good citizenship. It also emphasizes participation in community service programmes, development of life skills, soft skills, artistic endeavours, music, sports, and over all holistic development.

The institutional evaluation process for achieving the educational learning objectives of Programme Outcomes (POs) and Course Outcome (COs) starts systematically from the induction programmes to teaching methods used in the institute. It extends through the internal assessment system to the results of end-semester examinations, focusing on improvement of service effectiveness and coordination with students to attain institutional outcomes in teaching and learning process. First and foremost focus on the teaching methods;

**Consciousness in Teaching and Teaching Methods:**

1. Through well-planned curriculum delivery, regular classes are conducted to complete the syllabus within the given timeline. In case of disruptions, due to law and order situations, alternative arrangements like extra-class or special classes were conducted to ensure completion of the curriculum.
2. Faculty members inculcate the required skills and self-confidence in students through deep and effective teaching for achieving expected learning outcomes periodically.
3. The institute organises FDP in order to enhance the utilization of ICT tools and open learning resources as effective teaching methods.
4. Practical classes, tutorial classes, field visits, student exchange programmes, and internships are conducted regularly in teaching and learning process for the attainment of learning outcomes.
5. Awareness programmes, lectures, seminars, workshops, training sessions, cultural programmes, sports activities and observations are organized for the development of human values, true sense of being an Indian, ethical principles, socio-cultural awareness, religious understanding, traditional values, gender equity, constitutional obligation, innovative ideas, and community services.

**Continuous Internal Assessment:**

Awareness Programmes, workshops, and seminars for stakeholders on Intellectual Property Rights (IPR) and its importance of protecting intellectual assets, awareness among innovators and researchers about patenting, copyright, trademarks, other forms of intellectual property protection to promote IPR culture and the implications of violating IPR.

The institute has created an ecosystem for innovation and transfer of knowledge through the activities of various committees/cells to address various aspects of student and faculty development. These include the Internal Quality Assurance Cell (IQAC), Research and Development Cell, Sports and Cultural Committee, Academic Council to bridge the gaps in students' and faculties' skills, interests, and talents in diverse fields. As envisaged by NEP 2020, the College upholds Indian knowledge system (IKS) and is

committed to promote, present and spread awareness about cultural, linguistic, scientific heritage of India through collaboration and activities. Institution has signed 30 Memorandums of Understandings and offers 8 Certificate programs.

**Research and Development Cell:** It encourages and supports faculty and student research endeavours by providing them with necessary resources and guidance. From its inception, the college has fostered a robust research and study environment. It has an IBT HUB cum research centre within the Biotechnology Department featuring well-equipped sophisticated laboratories. Laminar airflow hoods, BOD Incubator, Light Microscopes, UV-spectrophotometer, PCR, Gel electrophoresis, etc. are among the high-end equipment available to faculty, research scholars, and students at the college.

**Cultural and Sports Committee:** By organizing cultural and sports events and competitions to showcase the talents and achievements of students Yoga and Thang-ta are integrated into the college system as a way of lifestyle and spiritual growth.

**Outcomes of the Institutional Ecosystem:** Faculty members actively engage in various research activities including publishing books, book chapters and research papers in reputed journals with some also presenting and publishing their work in conferences. During this period, 15 Faculty members have earned their Ph.D degrees from different reputed universities, with several others currently pursuing for their doctoral studies. A considerable number of Major and Minor Research Projects funded by University Grants Commission, and Department of Biotechnology, Govt of India have been sanctioned and successfully completed during this period.

The college organizes seminar, workshop, conference, faculty development programmes, outreach programmes, field trips, awareness campaigns, blood donation camps, NSS camps, and varieties of activities to interact with students, scholars, researchers and faculty members. As a part of its outreach initiatives, the college conducts surveys, project works involving students for societal benefits.

The college subscribed to the UGC scheme N-LIST which provides the teachers access to a wide range of online journals, books, data and resources. With great enthusiasm, students and faculty members prepare college magazine to showcase their creativity and also express their literary work. Subsequently, the college provide a greater platform for the students and faculty members to enhance themselves with knowledge and technology.

## Criterion 4 - Infrastructure and Learning Resources

### 4.1 Physical Facilities

#### 4.1.1

The Institution has adequate infrastructure and other facilities for,

- teaching – learning, viz., classrooms, laboratories, computing equipment etc
- ICT – enabled facilities such as smart class, LMS etc.

Facilities for Cultural and sports activities, yoga centre, games (indoor and outdoor), Gymnasium, auditorium etc (Describe the adequacy of facilities in maximum of 500 words.)

#### Response:

The college campus spans across **8.74 acres** of land, organized into five blocks, encompassing a total built up area of 2.91 acres. It has expanded its infrastructural facilities to one academic and administrative block, various cells and committee offices, **39 class rooms, 14 laboratories, one central library, 2 seminar halls, 1 multipurpose indoor hall, 1 auditorium, hostels for both boys and girls, and one Guest House.**

#### Classrooms

All classrooms feature adequate natural ventilation and abundant sunlight with essential teaching aids such as white boards, desk and benches, with few being upgraded with Interactive Smart boards, projectors and other modern teaching technologies.

#### Laboratories

The college has 14 meticulously maintained laboratories to conduct experiments for students and researchers; Physics department has a dedicated dark room with Computer Science, Mathematics and Biotechnology departments each house individual computer laboratories.

#### Seminar Halls

The institute has two seminar halls, an auditorium, and a court room dedicated to hosting seminars, workshops, conferences and invited lectures for both students and faculty members; fully equipped with LCD projectors, Wi-Fi connectivity, raised platforms and a comprehensive public address system.

#### Computing Equipment

The college has equipped with three computer labs, and each department is provided with desktop computers, laptops, all-in-one printers, and internet connectivity facilitating academic and co-curricular activities.

The institute is also equipped with **80 desktop computers, 31 laptops, two interactive smart boards, one electronic white board, one media lab, four projectors, two smart TVs, 32 All-in-One printers**

among other resources to support ICT-based learning and cater to day-to-day needs such as creating power-point presentations and distributing lecture handouts to students. The Moodle LMS is implemented for online teaching and learning since 2023-24 session. The campus features Wi-Fi connectivity with seven access points and LAN internet access supported by both 100 mbps BSNL broadband and 100 mbps WISTECH internet service.

Besides academic pursuit, the Sports and Cultural Committee organizes number of cultural programs, sports events aimed at fostering creativity, artistic expression, and holistic development. To ensure ample infrastructural support for games and sports, it has introduced four-year degree course in Physical Education and Sports Science under Manipur University since 2021. With NEP 2020, Yoga has been incorporated into the curriculum as a value-added and skill enhancement course. Every year, the International Yoga Day is celebrated with honour and enthusiastic participation from all.

The institute has one multipurpose indoor hall for playing indoor games like Badminton, Table tennis, Chess, etc. There is a spacious playground in the campus designated for outdoor games. Recently, a MoU with UCO, Kakyai was signed for promoting games and sports and to utilize its playground for outdoor games.

The College has a well-equipped gymnasium capable of accommodating 35-40 trainers simultaneously. The facility offers latest fitness equipments under the supervision of the PESS department.

The institute has one auditorium with a sitting for 300 individuals, dedicated for organizing cultural and literary programmes. Through the signing of a memorandum of understanding with Imphal Theatre, the college offers short term courses on stage performance and theatre workshops for students.

The primary objective of the College Central Library is to promote a conducive learning atmosphere and offer appropriate books or information to the intended users. The library guarantees seamless access to its resources and services for all users, employing the latest services and efficient automation processes.

#### **RESOURCES IN THE LIBRARY:**

The college central library is equipped with a numbers of resources such as:

A total number of 3,983 Text/Reference books are available across 18 disciplines; it also subscribes 3 national print magazines; 3 national & local newspapers; online e-resource consortia (N-LIST); 10 e-journals; 12 e-books; internet connectivity, 5 desktop computers, 1 Xerox machine etc.

#### **LIBRARY AUTOMATION:**

Library is currently operated within a semi-automated framework using Integrated Library Management Software (ILMS) KOHA 23.11.00 version enhancing library operations.

#### **OPAC:**

Online Public Access Catalogue is used since the installation of KOHA 23.11.00 version software for accessing resources available in the library.

#### **ONLINE E-RESOURCES:**

The Library is subscribed to N-LIST e-resource consortium for accessing e-resources. At present the library has more than 190 users in the N-LIST which include all the teachers, students and staffs of the college.

**LIBRARY USER:**

The library provides 26 cabin study tables for the users in the reading room section of the library and also the library provides 2 long tables with a sitting capacity of 12 users at a time for the periodical/newspaper user.

**INFORMATION TECHNOLOGY SERVICE:**

The library provides access to OPAC and online e-resources with a dedicated computer system for browsing. The library provides internet facilities through LAN and free Wi-Fi connection for bonafied library user only.

**OTHER SERVICES OF THE LIBRARY:**

Library provides photocopy and printing services with minimal charges from the students and college staff. The library automation system enhances its function and usability for faculty and students in their academic pursuit.

1. **Accessibility:** The digital facility enable 24/7 accessibility to resources, facilitating research and study regardless of time and location.
2. **User-friendly Interface:** The ILMS provides a user friendly interface for easy access to library resources by enhancing the overall experience for faculty and students.
3. **Search Capabilities:** the ILMS offers advanced search capabilities such as keyword search, subject indexing, and metadata retrieval, enabling users to efficiently locate relevant materials within the library's extensive collection.
4. **Resource Management:** The ILMS streamlines resource management tasks such as cataloging, circulation, and inventory management, allowing library staff to focus more on providing assistance and support to users.
5. **Integration with Learning Platforms:** National Digital Library through N LIST, Moodle LMS etc. allow seamless access to library resources directly from academic courses fostering a more integrated approach to teaching and learning.
6. **Research Support Services:** It provides a wide range of research support services to help students and faculty including assistance with literature reviews, citations management, research data management, copyright and intellectual property issues, and research publication.

**Response:**

The college has a comprehensive and well- equipped IT facilities for effective teaching-learning, evaluation and administrative functions.

1. **Internet connectivity:** The institute provides two internet connections one from BSNL with normal line and dynamic IP (100 mbps) and another from WISTECH private internet with leased line and static IP upgraded to 100 mbps from 50 mbps.
2. **Departmental LAN Ports:** All systems in the department are connected with internet through LAN ports.
3. **Wi-Fi Access Points:** There are seven Wi-Fi access points across the college campus at various sites viz., A Block, Library. IQAC, Computer Science department, department of BTT, Home Science department and Chemistry department.
4. **CCTV Surveillance System:** The College has installed CCTV surveillance system with 16 network cameras fixed at different strategic points to maintain security and discipline.
5. **Interactive Smart board and Electronic Whiteboards:** The institute has installed two interactive smart boards and one electronic whiteboard for conducting smart class to enhance e-learning.
6. **Computer Science Lab:** The computer science lab is furnished with 20 computers connected to internet facility through USB Wi-Fi dongles to conduct practical classes for students and training programmes for the faculty members.
7. **Mathematics Department Computers:** The mathematics department is equipped with 15 lab computers connected to internet through USB Wi-Fi dongles.
8. **B.VOC-IT Computer Lab:** The department is furnished with 8 computer lab connected to internet through USB Wi-Fi dongles.
9. **Educational Technologies:** The institute has adopted Moodle Learning Management System (LMS) to enhance online mode of learning more effective. The college website is deployed on the cloud and dedicated servers.
10. **College Management System:** The institute has a local server for the College Management System for handling student admissions, form fill-ups, student reports, etc.
11. **Library Facilities:** The College Central Library is equipped with 5 computers with internet facilities for easy access to e-resources for students. Library Automation has been operated using Integrated Library Management Software (ILMS) KOHA 23.11.00 version.
12. **Media Lab:** The institute has a media lab capable of recording audio and video classes for teaching and learning more effective and enjoyable.

## 7.2 Best Practices

### 7.2.1

**Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual**

**Response:****Practice-I: Infrastructural Development of the Kamakhya Pemton College, Hiyangthang.*****Objective of the Practice:***

Infrastructure plays an important role in an Academic Institution. Classroom design, conference halls, mini seminar halls, laboratories, botanical garden cum recreation centre, physical fitness centre, etc. are crucial elements of a learning environment.

Effective infrastructure planning for educational institutions is one factor that creates positive and conducive atmosphere for students learning. Be it a theory or a practical class, it must encourage students to get actively involved.

The institute provides the essential building blocks (physical infrastructure), technological systems (IT infrastructure), and education and knowledge acquisition (Learning Management). Physical infrastructure enables the construction and maintenance of IT infrastructure, while IT infrastructure facilitates communication and data sharing for learning resources through LMS. Learning resources again contribute to the development and improvement of all types of infrastructure.

***The Context:***

Classroom environment is one of the most important predictors of a student's achievement, where environment and design elements of the institution infrastructure have considerable impact on student's academic progress. Our institute is now targeting to complete 44 more classrooms other than the existing 39 class rooms by March, 2024 in view of the implementation of NEP-2020.

***The Practice:***

In HEI's laboratories, classrooms, botanical garden cum recreation center, hostel, indoor hall, smart classrooms, wi-fi enabled campus, library, canteen infrastructures, etc. while admitting a college for Degree Courses. All the classrooms, departments, corridors, seminar halls, administrative block, library, hostels, canteen, guest house, etc. are floored with proper tiling. One large Nongin Seminar Hall has a seating capacity of 250 participants with dedicated chairs, podium, projector screen (12x8 ft), sound, and attached separate washrooms for Ladies and Gents. One Mini Seminar Hall having a seating capacity of 75 individuals is also equipped with dedicated chairs; podium, projector screen (8x6 ft), and sound. Two Smart Class rooms are also set up with touch screen smart boards for effective interactive classes.

There is also a large indoor hall with facilities for GYM, Badminton, and Table Tennis provides students with an excellent way to stay active and engage in enjoyable leisure activities. This can contribute to their overall well-being and social life.

***Evidence of Success:***

Since 2011, all members of the Governing Body, Teaching and Non-Teaching Staffs of Kamakhya Pemton College, Hiyangthang have tremendously worked and invest all resources to bring about infrastructural development in all aspects.

***Problems Encountered and Resources Required:***

Despite limited resources, Kamakhya Pemton College strives to improve infrastructure and academic performance. Balancing staff well-being with development needs creativity. Seeking external grants, partnerships, or alumni support could be key to unlocking advancements. Their dedication to quality education amidst challenges is commendable.

***Other information relevant for adopting/ implementing the Best Practice:***

*Understanding the specific needs and priorities of the student's community, the Governing Body of Kamakhya Pemton College serve and approach towards the overall infrastructural development of the institute.*

***Facilities of Kamakhya Pemton College:***

1. *Up-to-date classrooms, smart classrooms, laboratories, and other learning spaces equipped with cutting-edge technology.*
2. *Accessibility in facilities that cater to diverse needs, including with disabilities.*
3. *The college has targeted to have 44 more classrooms other than the existing 37 classroom.*
4. *14 well equipped laboratories for systematizing and standardizing the learning process, ensuring wider access to knowledge and skills.*

***Practice-II: Solid Waste Management of the Kamakhya Pemton College, Hiyangthang.******Objective:***

To minimize the production of waste, proper solid waste management steps were taken and practiced in the entire campus with the support of students, faculties and non-teaching staffs of the college. The Boboi Kangleipak Solid Waste Movement System (BoKSWaMS), Langthabal Phuramakhong, I/W, Manipur-795003 is responsible for setting up a waste processing and disposal facility for managing the wastes in an environmentally friendly manner.

***The Context:***

Solid waste has become a major environmental issue due to depleting natural resources and raising concerns of climate change. Wastes can be classified as **biodegradable wastes** (food waste, garden waste and paper), **recyclable wastes** (paper, glass, plastics, metals, etc.), **inert wastes** (construction and demolition wastes, dirt, rocks and debris, etc.) and **hazardous wastes** (e-waste, paints, chemicals, light bulbs, fluorescent tubes, spray cans, fertilizer, pesticide containers, etc.).

***The Practice:***

The Kamakhya Pemton College, Hiyangthang is well equipped with different waste disposal collection dustbins, viz., Green coloured Dustbin for the disposal of biodegradable wastes; Blue coloured Dustbin for the disposal of non-biodegradable wastes; and Black coloured Dustbin for the disposal of domestic hazardous waste like sanitary napkins, diapers, blades, bandages, CFL, tube light, printer cartridges, broken thermometer, batteries, button cells, expired medicine etc. The campus also has seven Plastic Bottle Banks within the campus in a mission to be free from plastic wastes.



The existing waste management system includes the collection of waste on weekly basis from the canteen, academic block, hostels, and class room areas of the college campus. For other areas in the campus different coloured dust bins are provided, which are further collected by the Boboi Kangleipak Solid Waste Movement System (BoKSWaMS). The institute also combats waste through bottle banks and paper bag making, promoting sustainability.

***Evidence of Success:***

The following are the merits in the existing system:

1. The campus is fully a plastic free campus.
2. Different waste materials are collected in different coloured dustbins and facilitates efficient collection by the (BoKSWaMS).
3. Paper wastes from different departments were collected by the Eco-club and were reused for making paper bags and supplied to the College canteen.
4. To reduce waste at institute, students and staff are educated on proper waste management practices.

***Other information relevant for adopting/implementing the Best Practice:***

The solid waste management practice in college campus is commendable, but still there is a lot of room for improvement. An improved solid waste management system can easily be adopted in the college curriculum and as well practiced. The college authority should also provide training for its staff and students on various waste management programs so that they can become custodians of the environment. Once the good waste management practices are institutionalized, it will definitely trickle down to the society.

Out of 1656 students, 1532 number of students were cleared the Honours Course Examination at the passed percentage of 92.51. Out of 1162 students, 1008 students could clear the said examination at the passed percentage of 86.75.*
